Subject: - Activity schedule for Generation of Hall Tickets for AITT under CTS (Annual System) for the subjects of Practical, ED and theoretical (CBT mode) is to be held in December, 2021 for the following:

1. Regular Trainees annual system (Session 2019-2021 2nd Year)-CBT,ED & Practical
2. Regular Trainees annual system (Session 2020-2022 1st Year)- Only ED & Practical
3. Regular Trainees annual system (Session 2020-2021 1 Year & 6-month) -CBT,ED & Practical

Sir/Madam,

As discussed in the preparatory meeting with states held on 08.11.2021 for CTS examination, it is informed that AITT under CTS exam (Annual System) is proposed to be held in December, 2021 from 13/12/2021. To ensure the issuance of hall ticket to all eligible trainees through NCVT MIS Portal, the activities for hall ticket generation has to be completed by concerned ITI/SPIU on NCVT portal as per **activity schedule and time table is enclosed herewith as annexure-A.**

2. In view of the above, you are requested to strictly follow the specified dates as per Annexure-A and ensure entry of hall ticket eligibility criteria i.e. Sessional marks / Formative Assessment marks, Examination Fees and Attendance of trainees by the concerned ITIs under your control, so that hall ticket generated from NCVT MIS Portal can be provided to all the eligible trainees will in advance. Please follow the instructions attached as **Annexure-B** for details. **Candidates without NCVT MIS portal generated Hall Ticket shall not be allowed to appear in Practical and ED exam.**

3. The theoretical examinations for Trade Theory, Employability Skills and Workshop Calculation & Science (in CBT mode) shall be conducted from 20/12/2021. Further, as per order MSDE-19/01/(03)2019-CD dated 8th May 2020, Employability Skills subject will be conducted for 2nd year of 02 year trade also. In addition, states have to collect the CBT examination fee i.e., INR 376/- per candidate and have to make the payment to DGT/NIMI. The examination duration for CBT shall be as per **Annexure- C.**

4. All concerned should ensure to follow Govt. Guidelines and SoP regarding safety of staff and trainees from Covid19 during exams, as issued from time to time.



Technical Help

- (a) **Modes of Communication:** A user can communicate with the helpdesk in three ways: -
- (i) **Phone Number:** - Executives shall manage dedicated landline numbers. Where a user can call and log his issue. Any call made at the helpdesk shall be logged in the ticketing system (HP ASM) along with the action taken and solution provided.
- (ii) **Email:** - A user can also email to the helpdesk the helpdesk shall respond to the emails received, log a ticket, and record the action and the solution provided (if any) for such email.
- (iii) **User logs tickets through HPSM user portal:** - This functioning where a user can login with dedicated user id and password in HP ASM Tool and log a complaint, now a days this option is being used mostly and helpdesk team get notification for each new ticket logged and start working.

Subject: Implementation of revised Curricula of Employability Skills under Craftsmen Training Scheme (CTS) w.e.f August, 2019 admission.

Sir/Madam,

This is to inform that meeting of Recommendation Committee on Norms & Courses was held on 28th May, 2019 at Conference Room, DGT, Pusa, New Delhi wherein **enhancement of duration and contents for Employability Skills under CTS /ATS as an agenda no. 11 was discussed.**

Committee approved to enhance duration of curricula of Employability Skill from 110 hrs to 160 hours for 1st year of all CTS/ATS trades and also to develop additional 80 hrs web based module for 2nd year.

Accordingly, training hours has been enhanced from 110 hrs to 160hrs. In addition to trainees for 2nd year training have to taught 80 hrs web-based Employability Skills module.

The detailed curricula of the subject '**Employability Skills**' (1st year) is available on DGT weblink <https://dgt.gov.in/order-circulars> and content alongwith facilitated manual developed by NIMI is available on Bharat Skills portal. Web-based Employability Skills module of 80 hrs are under development by NIMI for the 2nd year trainees. This curricula will come into force w.e.f session starting August, 2019.
